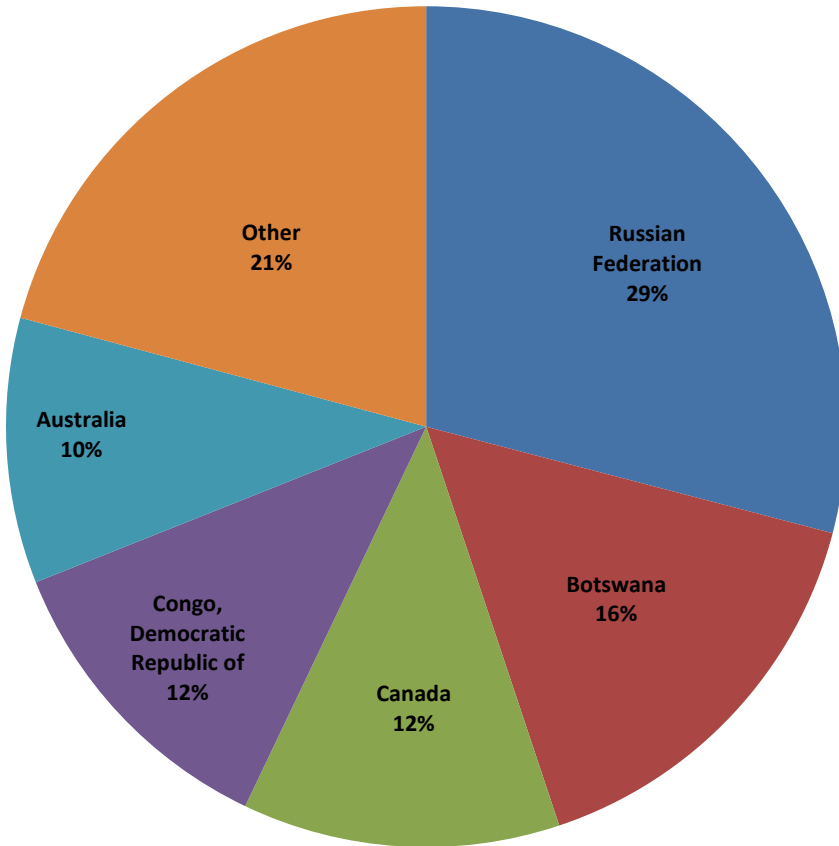


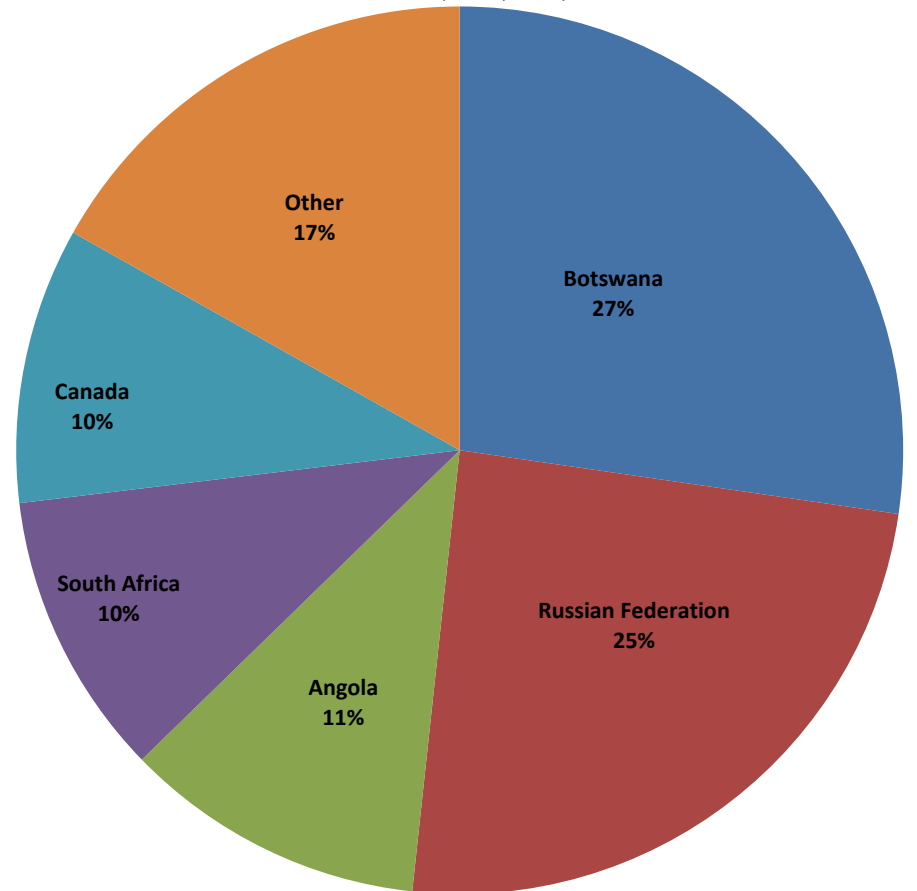
### Production By Volume (Cts)

### Production By Value (US\$)

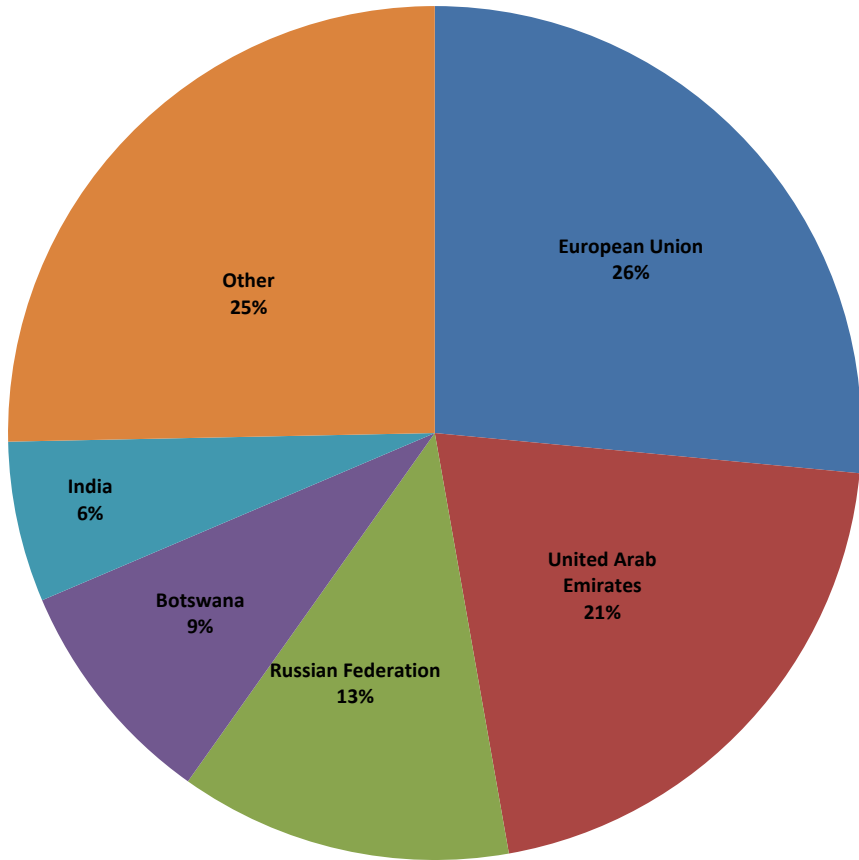

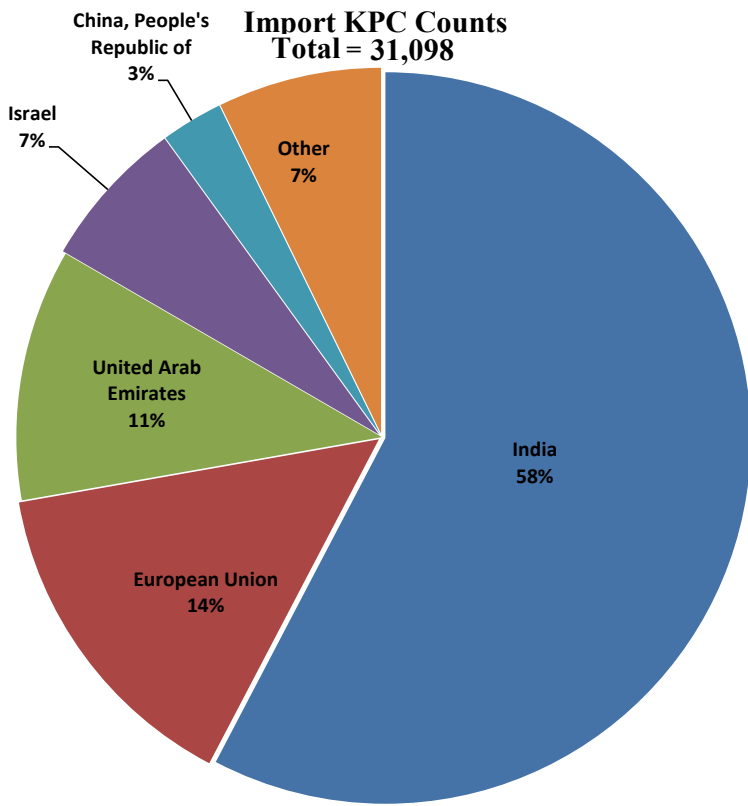
**Exports By Volume (Carats)**

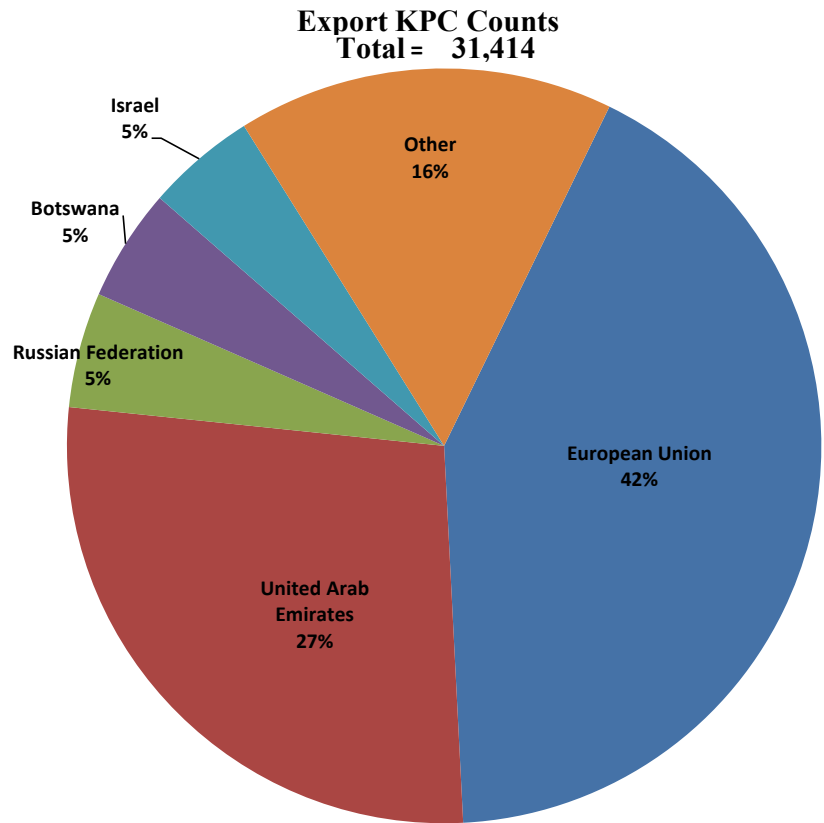
**Exports By Value (US\$)**
