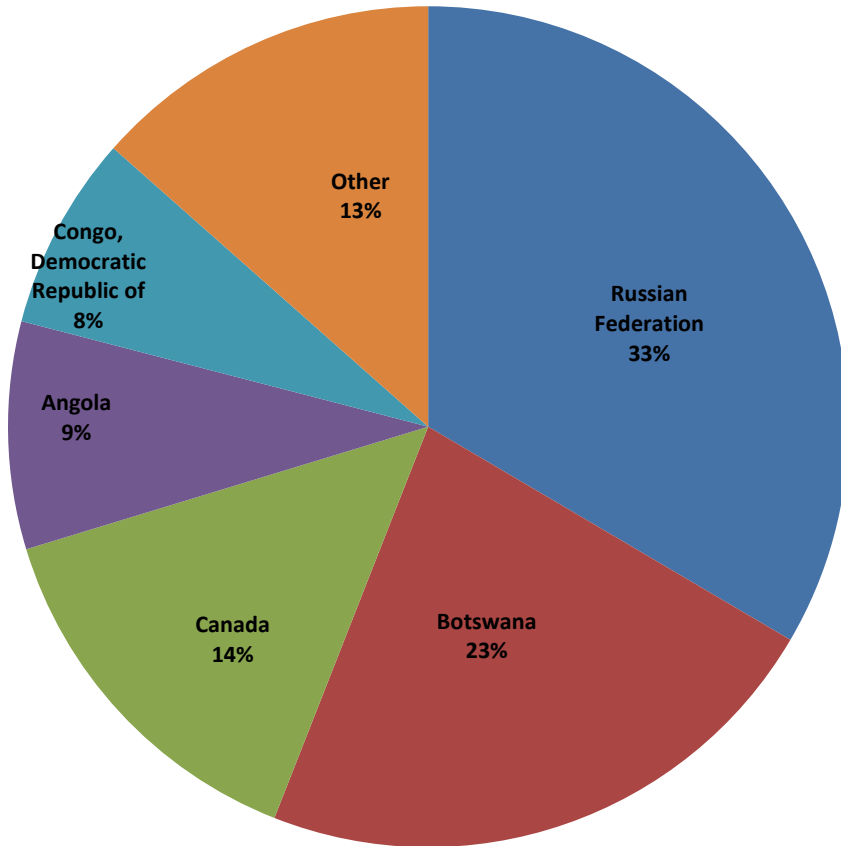


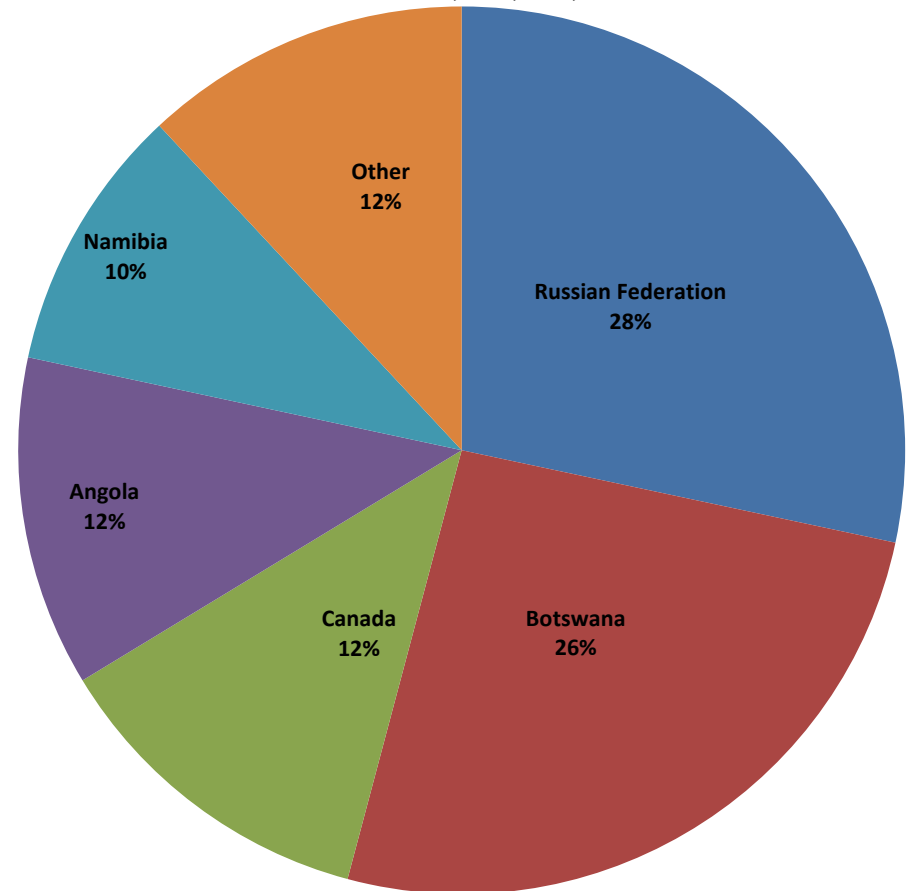
Production By Volume (Cts)

Production By Value (US\$)

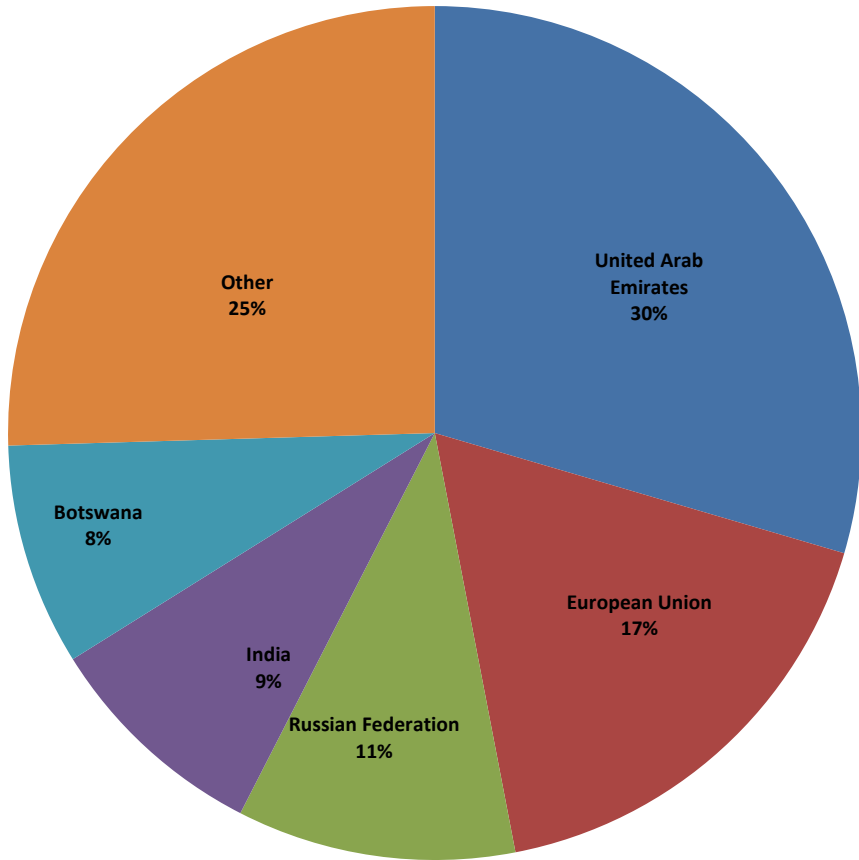

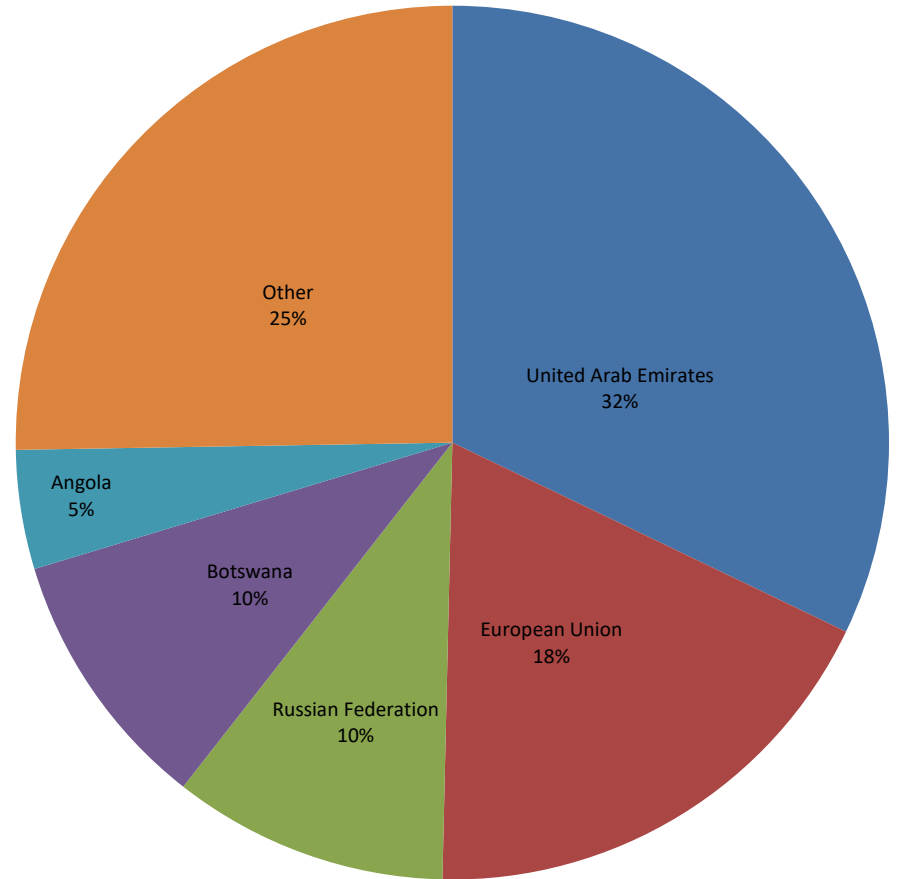

Total = 307,032,252.10

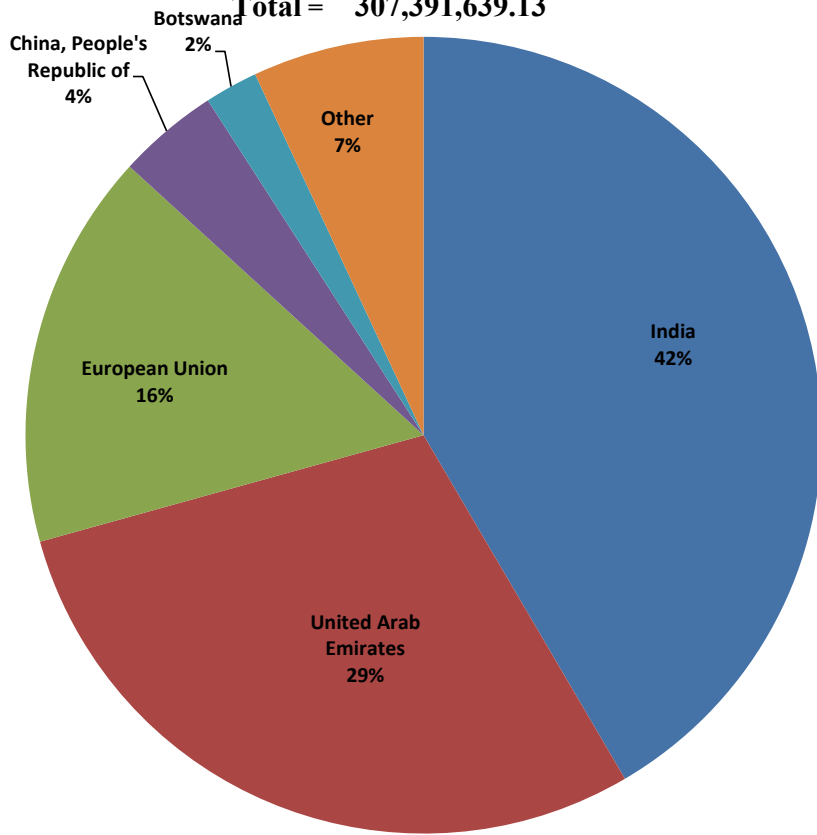


Exports By Value (US\$)
Total = \$36,039,547,420.55



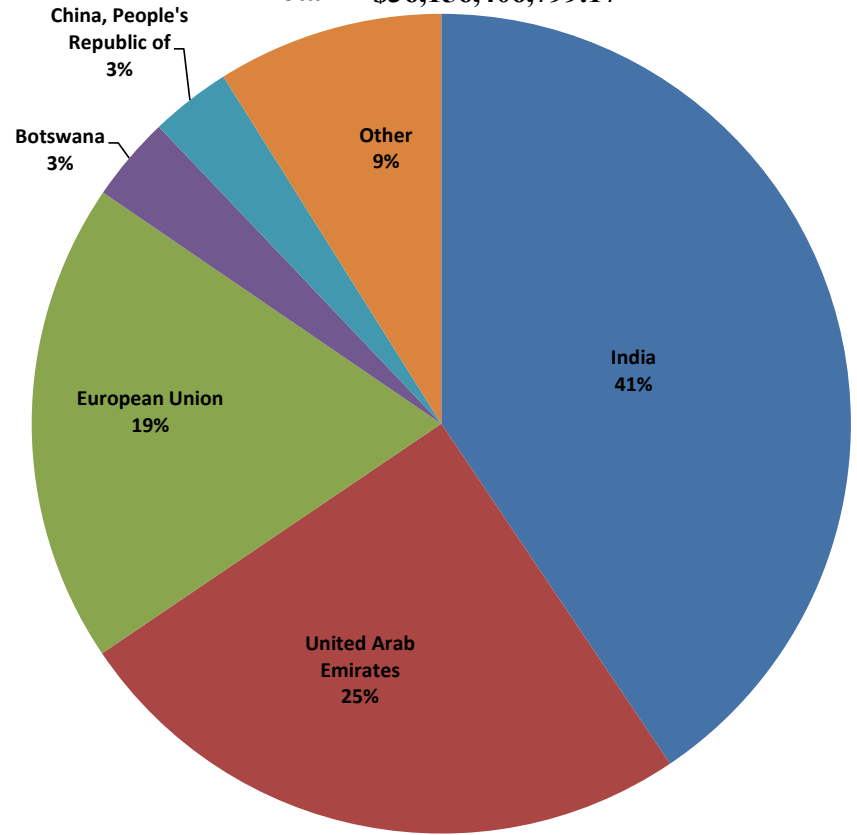
Import Volume By Carats

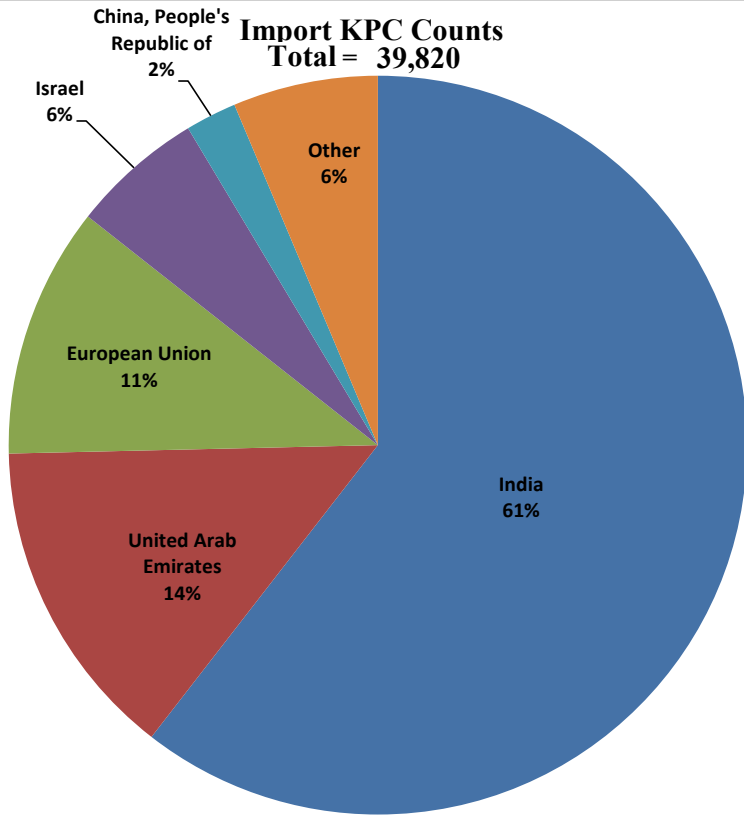

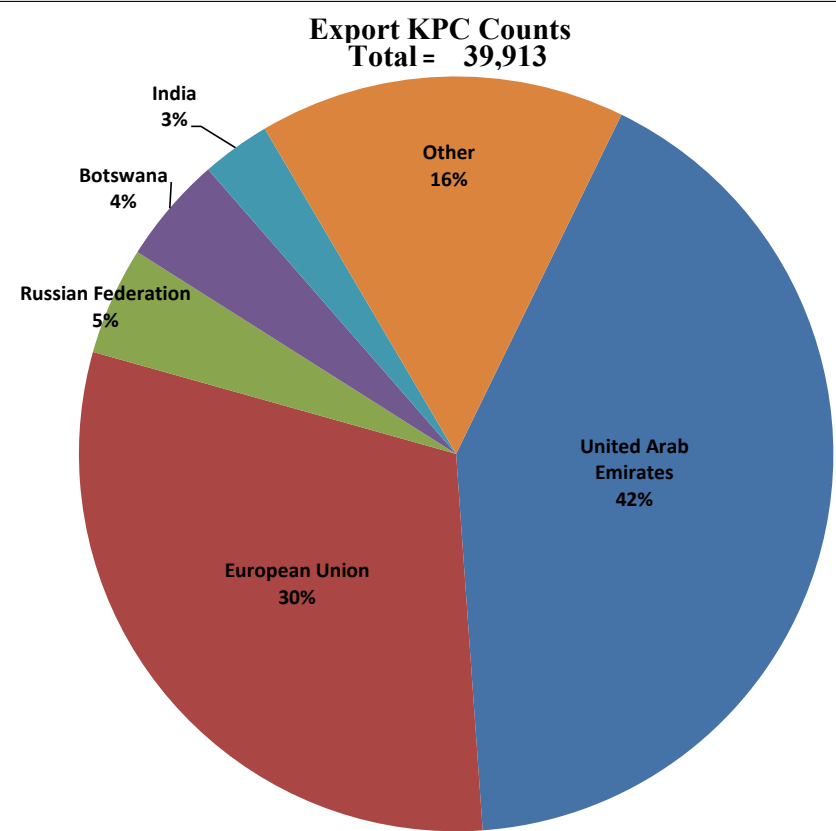
Import Volume By US
